Featured Trial of the Month –

New Medication for Uncontrolled Eczema – NIAID / NIH

Clinicians: *Do you have a patient age 18-65 with chronic atopic dermatitis?*

Perhaps they could benefit from a 7-month long study to assess the efficacy and safety of dupilumab, a recently FDA approved medication for moderate to severe atopic dermatitis. The study has two parts: a randomized, placebo controlled part followed by open-label dosing. Our researchers are trying to determine how dupilumab affects the immune system, water loss in the skin, and the amount of bacteria in the skin of adults with atopic dermatitis.

This study consists of 10 study visits over the course of 7 months.

NIH has released an article on their final report on Reducing Administrative Burden for Researchers: Animal Care and Use in Research (NOT-OD-19-136). NIH has been working for over two years with the FDA and the USDA, as well as research community and animal welfare advocates to consolidate and streamline the regulatory requirements across the three agencies while maintaining the safety and welfare of animals. National Jewish Health has been monitoring and adapting to new recommendations and processes as they

unfold. Positive impacts have already been felt with our most recent USDA inspection. Research Regulatory Affairs and the IACUC Office will continue to release updates as our processes evolve.
