

PULMONOLOGY

No More Mystery

Before arriving in Los Angeles, Orsola Diaz spent much of her life traveling to and from hospitals. Growing up in Italy, she'd always had a cough and runny nose — sometimes annoying, sometimes debilitating, but never fully resolved. And none of her doctors had an answer. "They usually said it was bronchitis," she recalled. "They would put me on antibiotics. I would stay at the hospital for a week, and then they would send me home. But it never went away."

By the time she moved to L.A. and started a family with her husband Robert Diaz, she'd had enough. "I would work and then get sick and have to stop. And it kept going on like that, until I just couldn't do it anymore. That's when a friend of the family recommended I go to National Jewish Health."


The resulting trip to Denver put her in touch with pulmonologist **Steven Lommatzsch**, **MD**, who reviewed her puzzling medical history and began a more precise examination. "We looked into genetic disorders," said Dr. Lommatzsch. "But the reason we were able to get there is because we could do nasal nitric oxide testing. Not a lot of places can perform this test. The equipment is costly, and, even when available, it requires careful calibration and maintenance. But it's one of the best ways to help diagnose primary ciliary dyskinesia with the other tools of biopsy and genetic testing."

Affecting 1 in 7,600 people, primary ciliary dyskinesia (PCD) is a rare, inherited condition that often goes undiagnosed, leaving people like Diaz without proper care for years, decades or even lifetimes. The condition affects the cilia in the lungs, which are small, hair-like structures that help move mucus and debris out of the airways. "If these cilia aren't moving correctly, as in PCD, the lungs aren't cleared of mucus and bacteria," said Dr. Lommatzsch. "When that happens, you get chronic infections that can cause serious problems if the condition isn't treated."

Working with Dr. Lommatzsch, Diaz was finally able to receive a diagnosis and the appropriate treatment for her condition, putting an end to a lifelong problem. "For years, she was just going from doctor to doctor. It was super frustrating," recalled her husband. "It wasn't until she got to National Jewish Health, where all the answers and all the treatment came together in one place."

After working with Dr. Lommatzsch, Diaz returned home with a brighter future, one that also has significant implications for her family. Because of PCD's hereditary nature, it was important for Diaz to make sure her three children didn't have the condition. Her four-year-old daughter is currently undergoing tests. If she's diagnosed with PCD, she'll have the answers and tools it took Diaz decades to find.

"It's been such a big change," said Diaz. "I'm so thankful to National Jewish Health and Dr. Lommatzsch."

Healing the Heart From Surviving to Thriving

In the spring of 1984, when most college students were planning summer vacations or applying for jobs, 18-year-old Tom Peterson was facing a life-altering diagnosis: non-Hodgkins lymphoma.

"I was active and athletic, growing up in Duluth, Minnesota, playing football, baseball and hockey," stated Peterson. "So it was quite a shock to find out that the swollen lymph nodes in my neck were cancer."

At the time, Peterson had his spleen removed and received full mantle radiation, a type of treatment that delivered high doses of radiation to the lymph nodes in the neck, chest and armpits. This treatment used in the 1980s became less common in the late 1990s due to its long-term side effects and the arrival of improved chemotherapy treatments. In 1989, after five years, he was considered cured.

However, 10 years later, Peterson began experiencing blackouts. Doctors discovered damage to the conductive part of his heart, likely a delayed radiation effect, and implanted a pacemaker. In 1997, Peterson moved to Colorado, and for nearly 30 years, he had no heart-related health issues beyond routine pacemaker replacements.

In December of 2022, while being treated for breathing difficulties, he received a CT scan, which revealed a severe hardening of the coronary arteries. A good friend recommended National Jewish Health as the "best in the business." Peterson began seeing pulmonologist **Rebecca Keith, MD**. She thoroughly reviewed his medical history and

connected Peterson's childhood cancer with his heart and lung symptoms and referred him to cardio-oncologist **Chris Fine, MD**.

"A cardio-oncologist is a heart doctor who specializes in problems caused by cancer treatments," explained Dr. Fine. "Testing revealed he had two malfunctioning valves and multiple blocked arteries and that surgery would be necessary."

In January of 2024, Peterson had two valves replaced, multiple blockages cleared, a coronary artery bypass and a new pacemaker. By April, he had recovered enough to return to work. Weekly follow-up appointments at National Jewish Health monitored his blood oxygen and medication levels and helped him stay positive.

"Before surgery, at 58 years old he had the valves of someone in their 80s or 90s," said Dr. Fine. "Now, his heart function is back to normal, and his symptoms are gone."

The work across disciplines to produce Peterson's result has been a major focus of the Division of Cardiology. "Along with our expanding imaging capabilities, this approach of weaving specialties together into one comprehensive system has improved the way we approach patients' cardiovascular issues," said **Glenn Hirsch, MD**, chief of the Division.

"I'm so thankful to be completely healthy again," said Peterson. "Getting the proper diagnosis and treatment was so very important. I hope other cancer survivors will get the help they need."

COMPLEX LUNG DISEASE

Spice of LifeA Chef's Recovery

Marvin Darnell oozes charisma. Meet him once, and it's easy to imagine the former chef charming customers late into the night at a fine dining steakhouse in Denver. He is happy to recall stories from his professional days in the '90s, when he rented a nine-room mansion for less than \$400 a month, throwing parties for family and friends, with rib eyes and crab legs bought wholesale.

"Those were great times," Darnell remembered, smiling.

Even though his parties these days are a little milder than those of yesteryear, Darnell is far from inactive. He exercises regularly and has been completing a variety of home renovation projects. He even started his own barbecue sauce business with his son, called *19*, after the number of spices required for his special recipe.

However, when he turned 52, Darnell began experiencing severe health problems that threatened to take the fun out of life, or worse if he didn't get help. He started feeling short of breath. His legs began to swell. Soon, even walking up a small flight of stairs became a difficult task. He spent 17 days at a local hospital, only to be told that the doctors didn't know the cause of his illness. Fortunately, he knew exactly where to go for answers.

"When I was a kid living in Bryan, Texas, I developed asthma," he said. "And they told my dad, 'You need to take your kid to this place called National Jewish Health in Denver. It's the best hospital for asthma there is.'"


This time, Darnell's condition was more severe and involved other diagnoses. "His sarcoidosis was pretty advanced," recalled pulmonologist **Clara Restrepo**, **MD**, who began working with Darnell in 2014. The disease had caused small lumps called granulomas to form in Darnell's lungs, and it was just the beginning. As he was being treated for his sarcoidosis, doctors discovered that Darnell also had pulmonary hypertension and chronic obstructive pulmonary disease (COPD).

The combination of these illnesses might leave most people feeling hopeless, but Darnell was confident in the care he'd first experienced as a child. Soon, the team rallied around him, with pulmonologists **Laurie Manka**, **MD**, and **M**. **Patricia George**, **MD**, joining Dr. Restrepo to provide a care regimen informed by their unique specialties in airway diseases and pulmonary hypertension.

Despite the severe nature of Darnell's lung diseases, the treatment he received soon helped him stabilize and begin to improve. "They put me on a trial for this new medication," said Darnell. "They also taught me techniques for how to breathe. I started to get a lot better."

It was a long road to recovery, but Darnell's indomitable character remained a constant. "He's a really remarkable individual," said Dr. Manka. "He's also what you hope for in a patient. He really took the therapies to heart. It made a huge difference."

"Dr. Manka would give me advice about what to take, and how to do things, and I listened," Darnell said. "I'm still here, and I'm still strong. I'm grateful to the staff at National Jewish Health, and I want to thank God for my recovery."

Taking Pain Off the Menu

Since she was a young girl, Taylor Wilson couldn't eat without having to worry about digestive problems. It seemed that every meal had the potential to cause severe stomach pain and disrupt her life. However, when she was diagnosed with celiac disease in 2014, Wilson was hopeful. "I just assumed everything would be better with a gluten-free diet," she recalled. "And it helped for a while, but then things just got worse."

Despite eliminating every trace of gluten from her home, she was still getting sick. "I thought maybe it was dairy, or that my meals were too fatty," she said, noting other strange symptoms. "I wasn't a big person to start with, and I lost 45 pounds over seven months," she said. "I remember stepping on the scale and thinking, What's happening to me?"

For years, she was given different explanations by doctors and friends. She was told it was likely cross-contamination, even though she took pains to cook her meals in separate pots and pans. It would often make her feel crazy, with no doctor seeming to take her words seriously.

By 2024, her symptoms had become impossible to ignore. At just 33 years old, a week after her wedding, she experienced a flare-up of diverticulitis, a condition that caused the small pouches in the lining of her colon to become inflamed. That's when she turned to gastroenterologist **Pranav Periyalwar, MD**, at National Jewish Health, who began taking a closer look at her

history of unexplained illness. "He actually listened to me," said Wilson. "It was a life-changing experience."

Realizing that previous treatments hadn't been working, Dr. Periyalwar conducted a series of tests for potential causes. "After we'd ruled out other conditions, we targeted a treatment for exocrine pancreatic insufficiency, which is when the body isn't producing enough digestive enzymes. It's a rare condition, but the symptoms lined up with what Wilson was experiencing," said Dr. Periyalwar. "And once we started her on that medication, there was a huge improvement."

Almost overnight, Wilson's symptoms dissipated, and for the first time in her life, the problem that had caused so much stress over basic meals had been diagnosed and treated all at once.

"I'll never forget. It was April of this year, opening day for the Rockies baseball season, which is a busy day for me since I work at the Rally Hotel across the street. And when I got home, my husband had ordered a gluten-free pizza, something I never eat because it always makes me sick. I had a slice and felt totally fine.

"It's such a little thing. But when you haven't been able to touch food for so long without feeling immobilized, having a slice of pizza is a huge win. Six months earlier, this same food would have made me violently ill, cramping in the fetal position," she said. "The whole experience was a game changer for me."

Meeting Patients Where They Are

As a nationally renowned rock climber, avid hiker and competitive ski racer, Rick Thompson was used to an active life in the mountain air. When he developed symptoms of sarcoidosis nearly 30 years ago, his life changed. Today, he remains committed to spending time outdoors, with the help of the compassionate, coordinated care he found at National Jewish Health.

Thompson grew up in Pennsylvania and began rock climbing at the Gnu River Gorge, developing the climbing area for future generations. He moved to Boulder, Colorado, in the late 1990s and co-founded one of the most influential environmental and conservation advocacy groups in the country — the Access Fund. Shortly after this move, he noticed a dramatic shortness of breath while doing his usual hiking.

After an extensive series of tests, Thompson learned he had sarcoidosis — an inflammatory autoimmune condition that can cause scarring in the lungs. He struggled with the available treatments for the disease. Medications that improved his breathing often came with difficult side effects, including extreme fatigue.

"When you take a person's energy, you really take their soul," he said. After years of chronic illness management and repeated flare-ups of the disease, his pulmonologist in Boulder suggested he seek care with an expert at National Jewish Health.


When Thompson began seeing **Lisa Maier, MD**, chief of the Division of Environmental and Occupational Health Services and leading sarcoidosis expert, it was a turning point. Dr. Maier understood her patient's goals and helped him trial several medications, searching for the treatment that would help him be outdoors as much as possible.

"Quality of life is incredibly important to our patients," Dr. Maier explained. "Our goal is to meet our patients where they are and develop treatment plans that support their aspirations."

Thompson describes Dr. Maier as "a real gift," noting the time and attention that she gives each patient visit. Her collaborative approach was also invaluable when Thompson developed pulmonary hypertension, a condition in which blood pressure in the lungs is abnormally high, as a result of lung scarring from sarcoidosis. To address this issue, Dr. Maier regularly coordinated with experts in cardiology, among other specialties.

Thompson's new treatment plan has restored his energy. He has shifted his passion for the outdoors to fly fishing, and often spends days on the river. He credits his improvement to the high-quality care he receives at National Jewish Health.

"They really want to understand you as a person," he said, "which seems impossible to find these days. The entire team at National Jewish Health stepped up to help me."





PULMONARY FIBROSIS

A Veteran's Health Victory

Luis Gonzales has always cherished his independence. A military veteran, he would usually spend his time working around his house and caring for his teenage son. But in late 2021, he was hit with a severe bout of COVID that left him so weak and breathless he needed a wheelchair just to make it to the hospital. When his doctors in Pueblo, Colorado, began performing tests, they suspected a deeper problem.

"They admitted me for about a week," said Gonzales. "They were just trying to make me comfortable, but then they said there was nothing more they could do. They said I needed to go someplace special, which was National Jewish Health. I don't even remember going for my first appointment. They had to take me in a wheelchair everywhere I went."

When Gonzales arrived in Denver, pulmonologist **Zulma Yunt**, **MD**, quickly identified what was behind his sudden decline. When he was infected with COVID, the sickness had revealed a serious, underlying disease: pulmonary fibrosis, a progressive scarring of the lungs that had likely worsened during his illness.

"He was very weak when I first I saw him," Dr. Yunt recalled. "At that point, I recommended him for a lung transplant, because his lung function was so poor, and we wanted to be prepared. However, we also started him on an alternate therapy for his lung scarring. We weaned him off the steroids he had been taking and began doing pulmonary rehabilitation with him."

His lungs on the brink of failure,
Gonzales listened closely to Dr. Yunt's
recommendations and strictly adhered to
the therapy, practicing new breathing
techniques at home and taking his
medications on time, all while understanding
that a lung transplant was a possibility.
During this time, he would check in with
Dr. Yunt, who monitored his progress.

"He just kept getting better and better," said Dr. Yunt. "Eventually, by the time he was getting evaluated for the lung transplant, he'd improved to the point where he didn't need one. And even after that, he was getting stronger."

It was an incredible recovery. With his lungs recovering, Gonzales was mobile again and able to work and drive. His family also started breathing easier. Earlier in the year, they joined him for a visit with Dr. Yunt, where Gonzales's son-in-law, also a veteran, presented her with a medal he received for service aboard the U.S.S. Cole after surviving a bombing attack. It was his way of thanking and honoring her for all she had done.

"They thought he wasn't going to make it," said Dr. Yunt, remembering the emotions in the room when she was handed in the medal. "It was so unexpected, and such an honor for me."

Now armed with new tools to maintain his lung health, Gonzales continues to see Dr. Yunt regularly. "I go to National Jewish Health every two months to recheck my lungs, to make sure I'm improving," said Gonzales. "Instead of going downhill, I'm going uphill."

Taking a BiTE Out of Small Cell Lung Cancer

Until recently, small cell lung cancer treatment was an area of oncology where new treatment methods were few and far between. However, last year, a novel class of immunotherapy called BiTE therapy (bispecific T-cell engager therapy) has given patients a promising new tool. This infusion of drugs empowers the immune system to fight cancer, helping doctors treat the aggressive disease.


"We've been using the same drugs to treat small cell lung cancer for over 20 years," said oncologist **Laurie Carr, MD**. "This is the hardest cancer to move the needle when it comes to new treatments."

Current small cell lung cancer treatment starts with chemotherapy, which gets less effective over time, and providers need to move to second- and third-line therapies to continue battling the cancer. This is where the new BiTE therapy drug, called tarlatamab, fits in.

The drug binds T-cells directly to small cell lung cancer cells, helping the immune system target the cancer specifically. It comes with fewer of the traditional side effects of chemo, like hair loss and exhaustion, but requires hospital monitoring when patients are starting on the treatment to make sure their immune system doesn't overreact to the medication.

While the drug's effectiveness can vary, Dr. Carr has seen success. Patients have been starting BiTE therapy after previously effective chemotherapy treatments stopped working. In general, the result of the infusions has been positive. Patients who respond have seen much less severe side effects than chemo, while the immunotherapy has had less impact on their lifestyle, as it helps slow the cancer.

"It's the magic you're looking for," Dr. Carr said about the treatment's success, "Better quality of life, and better response to the drug."

CHRONIC CARE MANAGEMENT

Improved Outcomes for Patients with Complex Conditions

For 48-year-old Jennifer Sparlin, living with pulmonary hypertension meant every day was a balancing act. The condition can make even simple activities feel exhausting and unexpected changes in her health could quickly become serious. That's why she enrolled in the National Jewish Health Chronic Care Management™ program earlier this year — a decision that has made a life-changing difference.

The program uses real-time data to connect, monitor and respond to patients living with complex conditions. Using home monitoring tools, participants share regular updates on their vital signs, such as oxygen levels, heart rate, blood pressure and weight. The information is reviewed by the patient's care team, who can reach out immediately if the numbers are concerning or indicate a possible problem. By combining patient-reported data with expert oversight, the program aims to catch potential problems early — when they are most treatable.

"Our goal is to help patients manage their conditions in real time, rather than react to crises," said **Stephen Frankel, MD**, executive vice president of Clinical Affairs. "This level of monitoring means we can intervene before health issues escalate."

For Sparlin, that daily connection provides reassurance and safety. "I submit my vital signs every morning. If something's off, they call me before it becomes an emergency," she explained. "That attention has kept me out of the emergency room more than once."

"Jennifer really does benefit from chronic care management," said pulmonologist **Kevin Rurak**, **MD**. "It lets us act quickly if we see things are changing."

For Sparlin, it's more than just a medical program; it's a safety net. "I know my care team is watching over me, even on the days I feel okay. I truly believe this program is adding days to my life."

PEDIATRIC EXPERTISE

Children are at the heart of our mission. Youngest Patients Benefit from Expanded Services

"Over the last year, the Department of Pediatrics has embarked on a journey to expand and enhance services to meet the ever-changing needs of its youngest patients while continuing to transform care through discovery," said **Pamela Zeitlin, MD, PhD,** Silverstein Chair of the Department of Pediatrics.

One of the key areas where this growth has been most noticeable is in pediatric pulmonary care, which remains critical for children with chronic lung conditions. Our team of specialists manages a wide range of pulmonary diseases and operates dedicated clinics for aerodigestive and





exercise tolerance issues. This year, **Alicia Della Volpe, MD**, joined the faculty, bringing expertise in general pulmonology and neonatal intensive care units (NICU). Her arrival strengthened our post-NICU program, collaborating with HCA HealthONE Rocky Mountain Children's at Presbyterian St. Luke's, which supports more than 2,000 NICU infants annually. These patients require close follow-up to monitor oxygen use and support healthy lung development.

As the department grew its pulmonary services, it also added a new treatment for another rising health concern: food allergies. Oral immunotherapy (OIT) has become an important new tool, helping physicians train the immune system to tolerate food allergens.

The department's physicians contributed to global research leading to the U.S. Food and Drug Administration approval of the first OIT drug for peanut allergy, Palforzia®. OIT involves regular patient contact with clinical staff, offering crucial opportunities for personalized education on managing food allergies and related challenges. "For infants with food allergies, starting OIT early — while the immune system is still developing — can help them quickly and safely build up a tolerance to the food and possibly change how their allergy develops over time," said BJ Lanser, MD, director of the Pediatric Food Allergy Program.

This year, the Division of Pediatric Behavioral Health also saw the addition of neuropsychological evaluations to its comprehensive suite of evidence-based assessment and psychotherapy. Pediatric neuropsychologist Mark Lott, PhD, joined as the new director of the behavioral health team. "Neuropsychological evaluations help identify issues in thinking, mood, behavior and relationships, as well as help clarify diagnoses, guide treatment planning and track how well our pediatric patients are improving," Dr. Lott explained.

Our clinical endeavors support the department's strong commitment to research and training, and our groundbreaking research takes a comprehensive approach to understanding, diagnosing and treating complex diseases. This work leads to improved outcomes for children with chronic and rare diseases and sets us apart as national leaders in research.

The department's reputation for pioneering research and clinical care draws physicians to the Pediatric Allergy and Immunology Fellowship program. "We are proud of this program," noted Dr. Zeitlin. "Because our clinicians see complex cases, fellows get experience that is not available elsewhere, ensuring younger generations of patients benefit from the expertise that only National Jewish Health offers."

Smaller Worries, Bigger World

When Keely Graff was just eight months old, a day care teacher noticed something troubling. She was getting sick after nearly every meal. Thinking a food allergy could be responsible, Keely's mother Tiffany brought her to National Jewish Health for treatment, where doctors confirmed her suspicions. Unfortunately, the extent of Keely's allergies went far beyond the usual suspects. Tests revealed a wide array of severe allergies. Everything from dairy to eggs, peanuts, soy, scallops and other items could cause an anaphylactic reaction, endangering young Keely's life.


"Keely has an incredible number and variety of food allergies, making her a very severe case," said pediatric food allergist **BJ Lanser, MD**, recalling his first encounter with Keely inside the hospital's Day Program. "For a kid to have to deal with that, it can be pretty daunting, and, of course, it's difficult for the parents too. That's why we needed to take action."

Over the years, Dr. Lanser worked with Keely to try to narrow down her long list of allergies. They also tried to increase her body's tolerance to peanut using an innovative allergy treatment. Keely participated in a clinical trial of peanut oral immunotherapy. Later, she started a new medication — the first ever approved for food allergy — so that the daily routine of stepping into a school cafeteria wouldn't be such a hazard. "There were times when I wasn't able to eat anything on the menu," said Keely, now 16.

Despite the uphill battle, her outlook was positive. "She has a great personality. She's very determined," said Dr. Lanser, recalling how Keely and the family would push for more food challenges and progress every year, chipping away at the mountain of allergies that had affected her since birth. Looking to speed up the process, Dr. Lanser started Keely on Xolair®, a biologic, which showed promise for complex cases by blocking the antibody that triggers allergic reactions. The treatment was an immense success. By the time she was in eighth grade, Keely was able to expand her diets in ways that had been unimaginable, with her medication providing a crucial safety net if she were accidentally exposed to small amounts of allergens.

"I had a few things that I shouldn't have had. This was before we did the test. I think I had flaxseed, and I'd had it in my body for two hours. We found out after reading the ingredients list for the bread, but I had no reaction whatsoever, and that's kind of how it's been. I haven't had any reactions for two years," Keely recalled.

With common foods no longer posing such a danger, Keely's world began opening up. This past summer, she took a trip to Switzerland and Italy. In the past, a trip like this would have been extremely treacherous, but this time, Keely didn't have to be so apprehensive. "This was the first trip I've never had to ask for ingredients," she said. "I would just pick out what I wanted and eat it. That was really life-changing. It was nice not having to be scared about a reaction anymore."


DISCOVERY SCIENCE

National Jewish Health has long been entrusted to lead discovery science and address society's most pressing health needs. The institution invests tens of millions of dollars every year into research that innovates and saves lives.

Fund to Safeguard Critical Research Protects Innovation and Discovery

Medical research is core to the National Jewish Health mission. Research and discovery lead to the creation of new treatments, better diagnoses and improved lives. Unfortunately, funding for research has become increasingly vulnerable, putting progress and discovery at severe risk. In response, National Jewish Health established the **Fund to Safeguard Critical Research** — an initiative that ensures critical studies continue even when traditional external support is uncertain.

The Fund provides flexible resources to sustain high-priority projects, bridge funding gaps and invest in innovative new ideas that might otherwise stall. The initiative includes early-stage studies with the potential to transform patient care, as well as clinical trials that directly impact patients with asthma, chronic lung and cardiac diseases, immune disorders, and rare conditions.



The Fund protects future breakthroughs, while safeguarding the science and researchers behind them. In its first year, the initiative supported multiple projects across immunology, genomics and respiratory medicine, giving scientists the ability to continue vital work without interruption.

"Our patients depend on us to push discovery forward," said **Gregory Downey, MD**, executive vice president of Academic Affairs and provost. "The Fund to Safeguard Critical Research is a lifeline that keeps innovation moving, no matter what challenges we face."

With vital support from its strong network of donors, National Jewish Health will continue to be a global leader in pioneering research and discovery science, bringing hope to patients today and for generations to come.

Research Accomplishments

Role of Macrophages Misunderstood in Fibrosis

Researchers at National Jewish Health and colleagues completed the first study comparing lung macrophages in multiple models of lung injury. Macrophages are immune cells that reside in and protect the lungs and are also recruited to the lungs in high numbers during disease or injury. They are key to the initiation and resolution of various types of lung injuries but are also involved in pathways that lead to lung scarring (fibrosis).

The research indicates that macrophages previously described as "pro-fibrotic" are insufficient to cause fibrosis on their own, opening the door to research that

can help advance the understanding of how macrophage programming — where signals influence the inflammatory properties of white blood cells — can help or hinder lung repair.

"We now know the role of macrophages have been misunderstood," said **William Janssen**, **MD**, section head of Critical Care Medicine and senior co-author of the research. "This research helps advance the goal of the pulmonary community to harness macrophages in the pursuit of achieving lung repair."




Cystic Fibrosis Drug Improves Pregnancy Outcomes

Pulmonologist **Jennifer Taylor-Cousar, MD**, and colleagues from across the country demonstrated that cystic fibrosis transmembrane conductance regulator (CFTR) modulator use during pregnancy may have a beneficial effect on maternal health, particularly lung function, and is likely safe for the exposed babies.

"This is the biggest study in the modern era of CF pregnancies," said Dr. Taylor-Cousar, co-director of the Adult CF Program. "There used to be 200 or fewer pregnancies for people with CF per year in the U.S., because women with CF died before childbearing age or couldn't sustain the pregnancy due to their disease. Pregnancy outcomes seem to be better for women who use modulators, and babies who were exposed to modulators during pregnancy were generally healthy."

Conducted across 11 U.S. adult CF centers, including National Jewish Health as one of the two lead sites, the study analyzed data from 307 pregnancies between 2010 and 2021. The results were published in the journal *CHEST*.



Protein Involved in Mucus-Related Airway Obstruction in People with Asthma Identified

Researchers identified a mechanism involved in the formation of mucus plugs in asthma. Mucus plugs are thick, sticky accumulations that can form in asthma patients, resulting in the blockage of airways. In patients with a subtype of asthma called type-2 (T2 high asthma), mucus plugs can block airflow and cause coughing, wheezing and shortness of breath.

"These changes in the molecular structure of mucus also alter its physical properties, making these mucus secretions sticky, viscous and difficult for patients to clear from their airways," said Max Seibold, PhD, director of the Regenerative Medicine and Genome Editing Program. The knowledge of this protein provides researchers with a potential new drug target for mucus obstruction in asthma patients. The study was published in the journal *Nature Communications*.



Dust Storms Linked to Increased Emergency Room Visits

A team of researchers led by **James Crooks**, **PhD**, found that dust storms in the Southwest represent a significant health risk, including an increase in emergency department (ED) visits for respiratory and cardiovascular conditions. Researchers analyzed over 33,500 ED visits across Arizona, California and Utah from 2005 to 2018. The findings indicate that dust storms are associated with a heightened risk of asthma, culture-negative pneumonia, chronic obstructive pulmonary disease, congestive heart failure, ischemic heart disease, cerebrovascular disease and motor vehicle accident admissions on the day of the storm or the days immediately following.


"Dust storms are expected to become more frequent due to climate change, so it's crucial that we understand their immediate and long-term health impacts," said Dr. Crooks. "Our study provides important data for public health officials to develop strategies aimed at reducing dust storm-related health risks."

The study, which utilized National Weather Service storm reports and patient-level ED records, emphasizes the need for improved warning systems and public awareness initiatives to mitigate dust storm-related health impacts.

Advanced Molecular Test Developed to Improve Diagnosis of Genetic Form of COPD

National Jewish Health researchers with the Advanced Diagnostic Laboratories developed a groundbreaking molecular diagnostic test capable of accurately diagnosing a major genetic cause of chronic obstructive pulmonary disease (COPD) known as alpha-1 antitrypsin deficiency (AATD). The test addresses a long-standing challenge in the medical community, as AATD is the second most common genetic lung disease in the United States, behind cystic fibrosis.

"AATD is widely underdiagnosed, leading to delays in treatment that can worsen disease outcomes," said **Yongbao Wang**, **PhD**, lead researcher and senior author on the paper. "Our test provides an accurate, comprehensive and rapid genotyping solution that can be implemented as a frontline diagnostic tool."

Defining 'Silicosarcoidosis,' a Distinct Occupational Lung Disease

Researchers at National Jewish Health and their collaborators in Colorado, Illinois, Taiwan and Israel have introduced a new term to the medical lexicon: "silicosarcoidosis." This novel designation describes cases where patients' lung tissue exhibits overlapping features of both silicosis and sarcoidosis, two serious pulmonary diseases associated with occupational exposure to respirable crystalline silica, commonly found in construction, mining and engineered stone fabrication.

The study was the first large case series to characterize silicosarcoidosis through lung biopsy definitively. The findings carry major implications for disease recognition, clinical treatment and occupational health policy.

"By coining the term 'silicosarcoidosis,' we hope to improve identification and diagnosis of this under-recognized condition," said **Jeremy Hua, MD**, lead author of the study and occupational pulmonologist. "Our work underscores the need for clinicians to consider occupational exposures when evaluating patients with sarcoidosis-like lung disease, especially those in high-risk professions."

Sarcoidosis is a systemic inflammatory condition of unknown origin, but it is increasingly being linked to environmental and occupational exposures. However, exposure histories are rarely sought during clinical evaluation. The new medical term can help bridge this gap by acknowledging silica exposure as a significant risk factor in some patients with sarcoidosis.



A New Chapter in Immunology and Genomic Medicine

This year, National Jewish Health welcomed **Derek Abbott**, **MD**, **PhD**, as the Cecil and Ida Green Chair of the Department of Immunology and Genomic Medicine. Dr. Abbott is recognized for his work at the intersection of genetics and immunology, with a strong track record of high-impact publications. He was previously at Case Western Reserve University School of Medicine, where he served as a Professor of Medicine in the Department of Pathology since 2006.


"I am honored to take on this leadership role at National Jewish Health," said Dr. Abbott. "I look forward to building on the department's legacy of discovery science and advancing research that improves the lives of patients worldwide."

Dr. Abbott's lab focuses on mapping nodal points in inflammatory and autoimmune disease using genetic data to guide drug development and improve therapeutic outcomes. His appointment comes at a time when there is considerable uncertainty surrounding medical research funding from the National Institutes of Health.

"National Jewish Health and its supporters are stepping up to meet these national funding challenges in a big way," said Dr. Abbott. "Now it's our responsibility as researchers to match

Building on this foundation, Dr. Abbott will oversee an ambitious research agenda and is poised to lead the department into its next era of innovation.



Nurturing Health Advocacy



"The students learn to be lifelong advocates for themselves," said **Julia Ethier, BSN**, manager of school nursing and student health services. "They all show remarkable improvement in their health and academics compared to before they enrolled." Despite this, some students still struggle with adhering to their physician-prescribed, at-home health plan — especially for asthma, which affects 73% of the students.

To understand why and help address this challenge, the kids became scientists this past year in a first-of-its-kind study with McCullough and physician-scientist **Eileen Wang, MD, MPH**. They gathered real-world evidence from fellow students and proposed new ideas to help improve at-home adherence.









"Parents commented that they had never seen their children so invested in schoolwork and that it inspired curiosity and great conversations," said Dr. Wang.

Using problem-based learning skills, which is part of the Morgridge approach, the students interviewed peers to understand hurdles at home and then came up with solutions to help their friends stick to a treatment plan. They shared their ideas and received feedback from experts in the community and at National Jewish Health. The young researchers then formed focus groups with family members and other caregivers to design a medical adherence program.

The team received a two-year grant to study whether the program improves adherence and self-advocacy for students throughout the school. Early feedback shows students willing to take advice from their peers, with one participant saying, "They know where I'm coming from — they're experiencing the same things."

Findings from the study will be published to equip adults everywhere with kid-approved and research-backed methods to help young people manage chronic illness.





Wellness and Prevention Clinics

Precision Screening and Care Powers Healthier Living

In today's evolving health care landscape, early disease detection and individualized support are key to living longer, healthier lives. The Wellness and Prevention Clinics at National Jewish Health share this philosophy through primary care programs that utilize precision medicine to promote healthy living and achieve improved outcomes. We are grateful for the generosity of the Irwin and Ginny Edlavitch Foundation, which helped us make this vision a reality.

Launched in 2024, the center's first program, Concierge Medicine, set the tone by providing members a personalized, evidence-based approach to primary care. Services include comprehensive wellness exams, nutrition counseling, illness management and coordinated care with specialists — all in one location. The program is membership-based, ensuring patients have the time and access they need to build meaningful relationships with their providers.

Following the opening of Concierge Medicine, National Jewish Health developed its Executive Health program to provide world-class physicals uniquely suited for high-performing business and community leaders. This program emphasizes lifestyle optimization for long-term health through in-depth assessments and wellness recommendations.

"We're redefining primary care with programs that focus on prevention, not just treatment," said **Girish Paranjape**, **DO**, physician with the Wellness and Prevention Clinics. "By combining precision screening with personalized care, we're helping our patients take control of their health in a proactive, impactful way."

Together, these innovative programs reflect the institution's commitment to advancing wellness through prevention, empowering patients to stay ahead of disease and lead healthier lives.

Advanced Diagnostic Laboratories

Expanding Efficiency and Capabilities

The Advanced Diagnostic Laboratories at National Jewish Health continue to strengthen their role as a national leader in specialized testing. Over the past year, the labs have expanded both their efficiency and their capabilities, ensuring patients and providers have access to cutting-edge diagnostic tools delivered with greater speed and accuracy.

Through a continued partnership with Siemens Healthineers®, the Core lab activated new analyzers this year. The equipment represents a significant upgrade to the lab's analytical testing capacity. They provide automated processes, freeing up more time for lab staff, while significantly increasing testing speed for chemistry and immunoassay tests for patients.

"By advancing both our technology and our operations, we're providing critical diagnostic insights faster and more reliably," said **Steve Groshong, MD, PhD**, medical director for the Advanced Diagnostic Laboratories. "This growth directly translates into better care for patients."

Immediate Care

Local Impact

Immediate Care at National Jewish Health plays a vital role in bridging the gap between routine doctor visits and emergency room services for both children and adults. Patients benefit from walk-in availability, ensuring prompt attention when they experience symptoms that suddenly worsen or when new health concerns arise.

"Having this resource on our campus has expanded our ability to help our patients and the broader Denver metro community access care," said **Carrie Horn, MD**, chief medical officer. "Unlike urgent

care centers, Immediate Care provides access to National Jewish Health expertise and specialists as needed."

Immediate Care also supports the Pediatric Triage Program. Parents may call the 24/7 Triage

Nurse Line for help with respiratory and allergy issues. When care is needed, patients are seen in the Immediate Care clinic, which is open seven days a week from 8 a.m. to 7 p.m. Parents like that Immediate Care works with each child's National Jewish Health doctor to make sure they get the care that they need.





Health Initiatives

Expanding Reach and Support for Tobacco Users Nationwide

The Health Initiatives department at National Jewish Health continues to play a leading role in reducing the toll of tobacco use nationwide. Operating tobacco cessation programs in 26 states, the team provides expert counseling, resources and support to help people of all ages quit tobacco for good.

This year, the department advanced its work by investing in new digital tools designed to improve access and engagement. The team redesigned the websites for both adult and youth cessation programs, a project informed by extensive user feedback gathered through focus groups and beta testing.

In addition, Health Initiatives launched a new mobile app for the **My Life, My Quit** program, which serves teens looking to quit vaping or smoking. Available through the Apple App Store and Google Play, the app provides coaching, tools and encouragement in a format designed for young people.

"These innovations ensure that no matter where someone is on their quit journey — whether an adult or a teen — they can access support in the ways that work best for them," said **Maria Rudie**, senior manager of products and services.

The team also welcomed new Executive Director **Alex Hurst** this year. Hurst has more than a dozen years of tobacco cessation program experience, serving as the director of the National Behavioral Health Network on Tobacco and Cancer Control for the National Council for Mental Wellbeing and managing the state of Louisiana's Quitline program.

"I'm thrilled to be joining the Health Initiatives team at such a pivotal time. The team has built a strong foundation in helping people quit tobacco, and I'm eager to build on that success, including scaling programs to reach the communities that need them most," said Hurst.



Key Partners Collaborate for Care and Research

National Jewish Health works and collaborates with partners in the local community and nationally. These relationships expand our clinical impact and open new research opportunities for discovery science.

Saint Joseph Hospital, a part of the Intermountain Health System (IMH) based in Salt Lake City, continues to be a strong clinical care partner, with advances continuing in the way we work together in key areas such as respiratory, critical care and cardiology. In addition, the collaboration generated between National Jewish Health and the IMH system throughout its seven-state area continues to grow.

Likewise, we continue our more than 50-year relationship with the University of Colorado School of Medicine, where we work to train the next generation of physicians and medical researchers, medical students, residents and postdoctoral fellows working in clinics and laboratories throughout our institutions.

Our intensivists continue to provide remote monitoring in intensive care units (ICUs) at 26 Banner Health hospitals across the western United States through our Tele-ICU program, now in its 11th year. And we continue to work with the University of Denver to develop educational and research opportunities. National Jewish Health *for Kids* provides diagnostic and treatment services for respiratory, allergic and immune system disorders on our own campus and through a relationship with Rocky Mountain Hospital for Children in Denver, which also includes work in the Neonatal Intensive Care Unit.

"We have continued to grow our collaborations through our Respiratory Institutes and through direct care collaborations with our partners," said **Jay Finigan**, **MD**, director of the Respiratory Centers of Excellence. "These unique models enhance how we all contribute on the clinical care side and improve our ability to create new and better ways to help patients."

Currently, we have worked together to establish Respiratory Institutes located at Mount Sinai Hospital in New York City, Jefferson Health in Philadelphia and Saint Joseph Hospital in Denver. In addition, we are continuing a key educational program with Thomas Jefferson University's College of Health Professions for Respiratory Therapy Training, an area that continues to have a nationwide shortage of trained staff.

FINANCIAL REPORT

Fiscal year 2025 marked a year of growth, resilience and strategic progress for National Jewish Health. We celebrated our 125th year advancing care, research and education. Despite a rapidly changing landscape, we continue to grow our innovative clinical and research programs.

In fiscal 2025, patient volumes increased year-over-year by 4.7%. The addition of new providers and growth in diagnostic testing led to a 6.5% increase in gross patient service revenue. Despite this growth, net patient revenues declined year-over-year by 6.2%. This decline was due to a substantial, one-time settlement from the Centers for Medicare & Medicaid Services (CMS) for prior year activities received in fiscal year 2024. After adjusting for this one-time payment, net patient service revenue increased by 3.9%, highlighting the continued expansion of patient care programs to meet increasing demand for our multispecialty services.

Health Initiatives had another outstanding year. National Jewish Health continues to be the largest provider of tobacco and vaping cessation services in the country, with revenues increasing year-over-year by 8%. Grant revenues also increased year-over-year by 4.6%. Despite the uncertain federal climate, National Jewish Health maintained ongoing support for groundbreaking research. We also continued our focus on clinical research trials, which increased by over 20% during the year.

Restrictions from pharmaceutical manufacturers related to the 340B Drug Pricing Program, a federal initiative which provides discounted pricing to hospitals serving a disproportionate share of underserved patient populations, resulted in a year-over-year decline in pharmacy revenues. Additionally, a donor who had given a large pledge in prior years fell on difficult circumstances, resulting in the write-off of a \$9.4 million pledge. Combined, this resulted in other income dropping 25.9% from 2024. On May 30, 2025, the governor of Colorado signed SB25-071, Prohibit Restrictions on 340B Drugs. This bill removes pharmaceutical manufacturer limitations on 340B access and will have a positive financial impact in future years.

National Jewish Health is grateful to our donors across the country, whose generosity has been steadfast for over 125 years. Fiscal year 2024 saw unusually large testamentary gifts, which did not recur in 2025. In spite of the drop in bequests, philanthropy raised over \$29 million. In March 2025, we successfully launched a major fundraising initiative, "Fund to Safeguard Critical Research," which led to a substantial increase in major gifts.

By being careful stewards of our resources, we successfully reduced expenses without compromising our mission. Though challenged by increasing wages, general inflation, investments in future growth and a challenging research environment, total expenses decreased year-over-year by \$16 million, or 4%. Cost containment measures will continue to be a focus into fiscal year 2026 as we adapt to a changing health care environment.

Fiscal 2025 was a pivotal year for National Jewish Health marked by meaningful progress, strategic adaptation and unwavering commitment to our mission. Amid a challenging health care and research environment, we strengthened our clinical programs, advanced discovery through resilient research efforts and expanded the reach of our nationwide Health Initiatives. We navigated financial headwinds with prudence and purpose, ensuring stability while positioning the institution for future growth. Though we made significant progress, it was a difficult financial year, as evidenced by the bottom-line loss of \$13.8 million. As we look ahead, we remain focused on safeguarding our legacy of excellence in respiratory and multispecialty care, accelerating innovation through research, and continuing to serve as a national leader in delivering high-impact, patient-centered care. With the ongoing support of our donors, partners and dedicated staff, National Jewish Health is well prepared to meet the financial challenges and opportunities of the years to come.






Patient Service Revenue (Dollars in millions)

Journey of Gratitude

From her home in Jackson, Wyoming, Maxine Murnick takes in views of the soaring Teton Range in the distance. She feels lucky to now call this pristine place her family's summer haven. She reminisces about their cross-country road trips from New Jersey to the West that helped them discover nature's splendor.

"When our kids were young, Ted and I loaded the trailer each summer, and we'd travel five or six weeks at a time," Maxine remembers about their adventures. "We visited as many national parks as we could, and we always detoured through Wyoming — because we loved it that much."

Maxine and Ted, her husband of 42 years, wanted their three children to connect, appreciate and see the world through a wider lens, while bonding as a family. Across the miles, the Murnicks imparted a valuable lesson of stewardship to their daughters, Lee and Amy, and son, Jay — which is reflected in their philanthropy to National Jewish Health.

For decades, Maxine has been among the most dedicated supporters of the hospital, and for nearly 25 years she has also been a member of the Council of National Trustees. Her giving began in the 1990s, in gratitude for the care Ted received as a patient living with severe asthma. Maxine had learned National Jewish Health in Denver was the best place in the country to seek treatment for his condition.

Maxine gives from her heart, to remember her beloved Ted, who passed away 15 years ago. She also sees her giving through the wider lens of impact she can make for medicine and for scientific research. In addition to establishing an endowed fund for pediatric research, Maxine has intentionally supported other promising research, by funding an Asthma Discovery Accelerator Program. Recently, she made a significant contribution that saved a critical research project endangered by public funding cuts.

She also demonstrates her dedication to philanthropy through her involvement and leadership positions at the Jewish Federation of Greater Metrowest, New Jersey. Currently she serves as president of their Jewish Community Foundation overseeing an endowment of more than \$700 million.

"When you are asked to help, you respond," explains Maxine. "I come from modest means but have been very fortunate. I believe it is my heartfelt obligation to try to make a difference where I am able."

Maxine has inspired this generosity in her now grown children. Remembering the commitment and compassion shown to their father at National Jewish Health when he needed care, Lee, Amy and Jay have become donors. Each one has also followed Maxine's example as active and engaged Trustees.

As the matriarch of the Murnick family, Maxine's journey of gratitude is helping lead the way for others — as far as the eye can see.
