	Internal Medicine Core: Provision of non-surgical treatment of general medical problems seen in the adult patient population	Requires successful completion of an ACGME or AOA accredited residency in Internal Medicine
	Allergy & Immunology Core in Occupational Medicine: Admission, history and physical, evaluation, diagnosis, provision of treatment, consultation, and discharge for patients presenting with allergic or immunologic conditions or disorders. Procedures include Fiberoptic Laryngoscopy, Rhinoscopy, and Immunotherapy procedures to include skin testing, food challenges, supervise allergen and irritant challenges, patch testing and interpretation, allergen desensitization and drug desensitization	Requires successful completion of an ACGME or AOA accredited fellowship in Allergy & Immunology
	Occupational Medicine Core: Admission, history and physical, evaluation, diagnosis, provision of treatment, consultation, and discharge for patients presenting with occupationally related or acquired conditions or diseases; procedures are not included	Requires successful completion of an ACGME or AOA accredited fellowship in Pulmonary Disease or Occupational Medicine
	Pulmonary Medicine Core: Admission, history and physical, evaluation, diagnosis, provision of treatment, consultation, and discharge for patients presenting with conditions or diseases of the organs and systems of the thorax or chest. Procedural privileges include Fiberoptic Laryngoscopy and Pleural procedures such as Chest Tube Insertion, thoracentesis, non-emergent intubation, and Closed Pleural Biopsy	Requires successful completion of an ACGME or AOA accredited fellowship in Pulmonary Disease
	Sleep Medicine Core: Admission, history and physical, evaluation, diagnosis, provision of treatment, consultation, and discharge for patients presenting with conditions or diseases related to sleep mechanics; core includes interpretation of Polysomnography, Multiple Sleep Latency Test, Maintenance of Wakefulness Test, Home Sleep Testing, and Actigraphy	Requires successful completion of an ACGME or AOA accredited fellowship in Pulmonary Disease or Sleep Medicine
Bronchoscopy and Related Procedures (must also request sedation privileges below)		
	Diagnostic Fiberoptic, Bronchoscopy with Bronchoalveolar Lavage, Endobronchial Brushings, Endobronchial Forceps Biopsy, Endobronchial Wash	Requires performance of at least ten Bronchoscopic procedures in each two-year appointment cycle
	Transbronchial Needle Aspiration	
	Transbronchial Lung Biopsy with or without Fluoroscopy	Requires State-mandated fluoroscopy training at initial appointment; thereafter, requires annual NetLearning Fluoroscopy module, plus hands-on, machine-specific proficiency review
	Endobronchial Ultrasound	Requires special training and approval

	Patch Testing and Interpretation (outside of A&I Core above)	Must provide proof of training and competence
	Provision of ICU Oversight via a Telemedicine Link	Required if working in eICU
	Mild to Moderate Sedation	Requires current ACLS and adult moderate sedation certification
