	Internal Medicine Core: Provision of non-surgical treatment of general medical problems seen in the adult patient population	Requires successful completion of an ACGME or AOA accredited residency in Internal Medicine
	Cardiology Core: Admission, history and physical, evaluation, diagnosis, provision of treatment, consultation, and discharge for patients presenting with conditions or diseases of the cardiopulmonary organs and systems. Procedural privileges include: EKG interpretation, echocardiogram interpretation, holter monitor interpretation, stress testing ECG interpretation, exercise stress testing supervision, pharmacologic stress testing supervision, event monitor/loop recorder interpretation, signal averaged electrocardiogram interpretation, stress echocardiogram interpretation, cardioversion, and evaluation and management of pacemakers	Requires successful completion of an ACGME or AOA accredited fellowship in Cardiology; Documentation of training/experience; ACLS certification
	Invasive Procedures Core: Includes: arterial line placement, advanced CPET and Fick CO measurement and interpretation, and intravenous contrast administration	Requires successful completion of an accredited Cardiology fellowship, including at least one year of invasive cardiology training; Core Cardiology privileges; Documentation of training/experience to include 50 cases as primary operator within the past 2 years
Cardiac Echocardiography		
	Echocardiogram, Echocardiogram with saline, and Echocardiogram with contrast	Requires Level II COCATS or higher experience, and National Board of Echocardiography certification; OR if trained prior to 1998, 3 years of echocardiogram reading experience with at least 1200 interpretations
	Transesophageal Echocardiogram	Requires 10 procedures every two years, and Sedation privileges below
Nuclear Cardiology		
	Cardiac PET Interpretation	Requires documentation of CBNC Nuclear Cardiology Certification
	Gated Blood Pool Scan Interpretation	
	Stress Radionuclide Interpretation	Requires level II or greater nuclear experience; CBNC Nuclear Cardiology Certification
Cardiac CT and MRI (requires Radiology Chair approval in addition to Department of Medicine approval)		
	Cardiac CT and CT Angiography Performance and Interpretation	Requires Level II or higher COCATS experience and Cardiac CT Board Certification (or board eligible with documentation of ABIM certification within two years of initial appointment)
	Cardiac MRI: Performance and Interpretation	Requires Level II or higher COCATS MRI experience
	Cardiac MRI: Interpretation Only	

Other Procedures	
LINQ Implants: insertion and removal	Requires documentation of experience or proctoring for first five procedures
Fluoroscopic Radiation	Requires State-mandated fluoroscopy training at initial appointment; thereafter, requires annual NetLearning Fluoroscopy module, plus hands-on, machine-specific proficiency review
Mild or Moderate Sedation	Requires current ACLS and adult moderate sedation certification
